DESCRIPTION OF REQUIREMENTS

The United Nations Office on Drugs and Crime Regional Office for Central Asia (UNODC ROCA) hereby invites qualified bidders to submit their Expression of Interest to conduct a victimization survey in Fergana Valley of Uzbekistan.

The aim of the survey is to study the problem of crime, as well as ways of their more effective solution, to investigate the subjective aspects of crime: fear of crime, fears and strategies of self-defense. And also provide a valuable source of information for law enforcement agencies and any national stakeholders responsible for crime prevention. The survey results can be used to understand the level and nature of both personal and domestic crimes, as well as people's perception of safety in society and their trust in law enforcement agencies. Both actual and perceived risks of crime can be indicators of the well-being of a society.

The assessment will determine the nature, extent and differentiation of crimes, and the answers needed, including:

- opinion of the population about the problems of crime in Fergana Valley, Uzbekistan
- trends, patterns and policies regarding corruption
- experience and results of reporting crimes to government agencies
- · citizens' access to justice
- the scale of crime and its nature
- characteristics of victims and criminals
- assessment of the likelihood of becoming a victim of a crime
- the degree to which the fact of committing a crime has been brought to the attention of state authorities
- reasons for refusing to report the committed crime
- the effectiveness of measures to prevent crime
- assessment of the presence / absence of a connection between the fear of crime and the real scale of crime
 - the impact of crime on vulnerable groups in society
 - dynamics of ideas about the safety of citizens.

The study aims to collect evidence about the forms of crime that affect the daily life of citizens in order to assess their prevalence and prevailing types. This information will be placed in a broader context by examining perceptions of crime, citizens' views of governance and public integrity and accountability practices.

Please note that this is not an invitation for submission of a proposal. This is a request for Expressions of Interest (EOI) in order to identify qualified vendors interested in participating in the solicitation.

Vendors interested in the above supply must provide the completed Vendor Response Form (attached on page 3). UNODC ROCA will examine this EOI and reserves the right to select the invitees for competitive bidding. Accordingly, an expression of interest does not automatically warrant an interested vendor's participation in the competitive bidding exercise.

UNODC ROCA reserves the right to change or cancel any of this requirement at any time during the EOI and/or solicitation process.

Целью исследования «Исследование виктимизации от преступности в Ферганской долине, Узбекистан» является изучение проблемы преступности, а также пути их более действенного решения, изучение субъективных аспектов преступности: страху перед преступностью, опасениям и стратегиям самозащиты. А также предоставить ценный источник информации для правоохранительных органов и любых национальных заинтересованных сторон, ответственных за предотвращение преступности. Результаты опроса могут быть использованы для понимания уровня и характера как личных, так и бытовых преступлений, а также восприятия людьми безопасности в обществе и их доверия к правоохранительным органам. Как фактические, так и предполагаемые риски совершения преступлений могут быть показателями благополучия общества.

Оценка будет определять характер, степень и дифференциацию преступлений, а также необходимые ответы, включая:

- мнение населения о проблемах преступности в Ферганской долине, Узбекистан
- тенденциях, моделях и политики в отношении коррупции.
- опыт и результат сообщения о преступлениях в государственные органы;
- доступ граждан к правосудию;
- масштабы преступности и ее характер;
- особенности потерпевших и преступников;
- оценка вероятности стать жертвой преступления;
- степени доведения факта совершения преступления до органов государственной власти;
- причины отказа сообщать о совершенном преступлении;
- эффективность мер по предупреждению преступности;
- оценка наличия/отсуствия связи между страхом преступности и реальными масштабами преступности;
 - воздействие преступности на уязвимые группы общества;
 - динамика представлений о безопасности граждан.

Исследование направлено на сбор доказательств о формах преступлений, влияющих на повседневную жизнь граждан, для оценки их распространенности и преобладающие типы.
