### **DESCRIPTION OF REQUIREMENTS**

The United Nations Office on Drugs and Crime Regional Office for Central Asia (UNODC ROCA) hereby invites qualified bidders to submit their Expression of Interest for development of standard operating procedures based on essential services package.

The task of the assignment is to work with relevant government stakeholders to improve multi-sectoral coordination in order to have increased capacity to deliver quality and coordinated essential services, including access to justice based on development of guidelines and Standard Operating Procedures (SOPs) in reliance with Essential services package.

Based on the participatory mapping of existing essential services in the Kyrgyz Republic, Standard Operating Procedures for police investigation, forensics, medical forensic and prosecution services will be developed and introduced to deliver coordinated essential services and better access to justice, to women and girls' survivors of violence, especially those facing multiple and intersecting forms of discrimination. Implementation of the Essential Services Package and Multi-sectoral Response Model are important first steps to institutionalize quality and effective services within the government plans and budgets.

Please note that this is not an invitation for submission of a proposal. This is a request for Expressions of Interest (EOI) in order to identify qualified vendors interested in participating in the solicitation.

Vendors interested in above tasl must provide the completed Vendor Response Form (attached on page 3). UNODC ROCA will examine this EOI and reserves the right to select the invitees for competitive bidding. Accordingly, an expression of interest does not automatically warrant an interested vendor's participation in the competitive bidding exercise.

UNODC ROCA reserves the right to change or cancel any of this requirement at any time during the EOI and/or solicitation process.

### SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

Целью задания является работа с соответствующими государственными заинтересованными сторонами с целью улучшения межотраслевой координации и повышения потенциала по предоставлению качественных и скоординированных основных услуг, включая доступ к правосудию, на основе разработки руководящих принципов и стандартных операционных процедур (СОП) в соответствии с пакетом основных услуг.

На основе совместного картирования существующих основных служб в Кыргызской Республике будут разработаны и внедрены стандартные операционные процедуры для следователей, судебных экспертов, сотрудников медицины и органов прокуратуры для предоставления скоординированных основных услуг и улучшения доступа к правосудию для пострадавших от насилия женщин и девочек, особенно тех, кто сталкивается с множественными и пересекающимися формами дискриминации. Внедрение пакета основных услуг и многоотраслевой модели реагирования - важные первые шаги к институционализации качественных и эффективных услуг в рамках государственных планов и бюджетов.

### 1) Registering as a Vendor with the United Nations
