

## Expression of Interest (EOI)

The United Nations Office on Drugs and Crime (UNODC), Country Office Pakistan in consultation and collaboration with the Narcotics Control Division plans to implement a pilot project 'Drugs prevention, treatment and care for drug using children and adolescents on the streets and their drug using family members' in Lahore.

The primary goal of this project is to provide drugs prevention, treatment and care services to drug using children and adolescents on the streets and their drug using family members in the city of Lahore. The services will include the establishment of outreach services (awareness raising & counseling on drug use prevention, harmful effects/consequences of using drugs, diseases associated with drug use, HIV and AIDS, HIV modes of spread & methods of protection, social services, screening for drug use, motivational counseling, referral to DIC, family visits and counseling, follow up etc.) and drop-in-centre (social services, screening & assessment, client registration, medical services, counseling services including motivational counseling, referral for drug treatment and other support services like shelter, referral to need based services which may include HIV and Hepatitis treatment and care services or any other advanced medical care etc.)

**Eligibility Criteria:** NGOs not fulfilling the following eligibility criteria will not be eligible for further consideration.

1. Five years since registration with the Government. Submit registration certificate with the Government.
2. The NGO should be based in or should have an office in Lahore. Submit proof of presence of the NGO in Lahore.
3. Submit audit reports of the NGO for the last two years.
4. Minimum 5 years experience in drugs prevention, treatment and care interventions, preferably targeting street children/adolescents.
5. For provision of standard quality drug treatment services to the children/adolescents, the NGO should have its drug treatment facility available for children/adolescents in Lahore (please provide information about the NGO's drug treatment facility for children/adolescents) or have strong established network with drug treatment facility for children/adolescents in Lahore. In such case the agreement with the other drug treatment facility and its profile including relevant experience should be submitted.

Please provide detailed profile of the NGO including experience/capacity of NGO specially experience in drugs prevention, treatment and care, highlighting drugs prevention, treatment and care interventions with street children/adolescents. Also please provide information about the NGO's drug treatment facility for children/adolescents.

Please submit the required documents in sealed envelope to the address mentioned below. Please mention the name of applying NGO on the envelope. Also mention on the envelope, Expression of Interest - Drugs prevention, treatment and care for drug using children and adolescents on the streets and their drug using family members' in Lahore.
