Pursuant to article 63 of the Convention, a Conference of the States Parties to the Convention has been established to improve the capacity of and cooperation between States Parties, to achieve the objectives set forth in the Convention and to promote and review its implementation.

The Government is cordially invited to participate in the fourth session of the Conference of the States Parties to the United Nations Convention against Corruption, which will be held at the Palmeraie Golf Palace Complex (PGP), Marrakech, Morocco, from 24 to 28 October 2011.

Pursuant to the decisions taken by the Conference at its third session, the Conference is expected to concentrate on key issues regarding review of the implementation of the Convention, asset recovery, prevention and technical assistance. Furthermore, and in line with one of the major objectives of the Convention and its Review Mechanism, namely, support to the efforts of developing countries to implement the Convention through targeted technical assistance, the host Government wishes to put particular emphasis on the achievement of the Millennium Development Goals and action against corruption. This is a much welcomed initiative as it is in line with the attention given to the matter in paragraph 52 of the outcome document of the High-Level Meeting of the General Assembly on the Millennium Development Goals at its sixty-fifth session, adopted by the Assembly through resolution 65/1, and is fully consonant with the Secretary-General’s priorities for the Organization. In keeping with past practice, the general discussion of the Conference will serve as an opportunity for high-level representatives to address the Conference, providing guidance for its deliberations and the achievement of its objectives. In view of the importance given by the host Government to the event, the significance of the matters to be discussed by the Conference and the need to reach key decisions, the Government is encouraged to be represented at the highest possible political level and to include in its delegation policymakers and experts on the issues to be covered by the Conference.

The rules of procedure also provide that the credentials shall be issued by the Head of State or Government, by the Minister for Foreign Affairs or by the Permanent Representative to the United Nations of the State party in accordance with its domestic law or, in the case of a regional economic integration organization, by the competent authority of that organization.
