Implementation Review Group (resumed 4th session) and Expert Meeting on International Cooperation  
(2<sup>nd</sup> meeting)

The Secretary-General of the United Nations presents his compliments to the **[[[FunctionalTitle2]]]** and has the honour to inform the Government that the following subsidiary bodies of the Conference of the States Parties to the United Nations Convention against Corruption will convene their next meeting in Panama City, Panama.

In compliance with resolution 4/2, entitled “Convening of open-ended intergovernmental expert meetings to enhance international cooperation”, adopted by the Conference of the States Parties to the United Nations Convention against Corruption at its fourth session, held in Marrakech, Morocco, from 24 to 28 October 2011, the Conference decided to convene open-ended intergovernmental expert meetings on international cooperation to advise and assist it with respect to extradition and mutual legal assistance and to convene one such meeting during its fifth session. **The second meeting of the Open-ended Intergovernmental Expert Meeting on International Cooperation will be held on 25 and 26 November 2013 in Plenary II, at the Atlapa Convention Center in Panama City, Panama.**

At its fourth session held in Vienna, from 27 to 31 May 2013, the Implementation Review Group decided to hold its resumed fourth session in parallel with the fifth session of the Conference of the States Parties to the United Nations Convention against Corruption. This was deemed necessary to permit the Group to give full consideration, inter alia, to the thematic reports prepared by the Secretariat and to the results of its work for appropriate transmission of its conclusions and recommendations to the Conference at its fifth session, in accordance with its mandate. **The resumed fourth session of the Implementation Review Group will be held on 26 and 27 November 2013 in Plenary II, at the Atlapa Convention Center in Panama City, Panama.**
