## **A. Introduction**

1. Article 63 of the United Nations Convention against Corruption (UNCAC)<sup>1</sup> establishes a Conference of the States Parties with a mandate to, inter alia, promote and review the implementation of the Convention.

2. In accordance with article 63 paragraph 7 of the Convention, the Conference has established at its third session, held in Qatar in November 2009, the Mechanism for the Review of Implementation of the United Nations Convention against Corruption. The Mechanism was established pursuant to article 4, paragraph 1, of the Convention against Corruption which states that States parties shall carry out their obligations under the Convention in a manner consistent with the principles of sovereign equality and territorial integrity of States and non-intervention in the domestic affairs of other States.

3. The Review Mechanism, of which this report forms part of, is an intergovernmental process with the overall goal being to assist States Parties in their implementation of the United Nations Convention against Corruption.

4. The Review Mechanism is based on a range of guiding principles enshrined in Conference of States Parties resolutions 1/1 and 2/1. In order to achieve its goal, the Mechanism uses a combined self-assessment / peer / group review method for reviewing the implementation of the Convention.

5. Each State party shall be reviewed by two other States parties. The review process shall actively involve the reviewed State. As an initial step, each State party shall provide to the secretariat the information required by the Conference on its compliance with and implementation of the Convention, using the self-assessment checklist developed by the Secretariat.

6. The review team shall carry out a desk review of the checklist response of the State party under review. Such desk review shall entail a [preliminary] analysis of the response focused on the identification of normative gaps, as well as technical assistance and capacity-building needs.

7. Throughout the review process, members of the review team engage in a constructive dialogue, discussing preliminary findings and requesting clarifications or additional information or address supplementary questions related to the review. This is being done by way of conference calls, videoconferences and e-mail exchanges, as required and facilitated by the secretariat.

8. All States Parties are subject to the review through the Mechanism. The Mechanism gradually covers the implementation of the entire Convention. Phases and cycles of the review process, as well as the scope, thematic sequence and details of such review, have been established by the Conference, together with each review cycle and the number of States parties participating in each year of the review cycle.
