Reference: CU 2009/79 (A) implementation review

The Secretary-General of the United Nations presents his compliments to the [FunctionalTitle] and has the honour to draw the attention of the Government to resolutions 1/1 and 2/1 of the Conference of the States Parties to the United Nations Convention against Corruption, on “Review of implementation”.

In its resolution 1/1, the Conference of the States Parties agreed on the necessity of establishing an appropriate and effective mechanism to assist it in the review of the implementation of the Convention.

Resolutions 1/1 and 2/1 of the Conference provided that the mechanism to assist the Conference in the review of the implementation of the Convention should have a range of characteristics and reflect a series of principles.

In its resolution 2/1, the Conference decided that the Open-ended Intergovernmental Working Group on Review of the Implementation of the United Nations Convention against Corruption shall prepare terms of reference for a review mechanism for consideration, action and possible adoption by the Conference at its third session. It further decided that the Working Group shall hold at least two meetings prior to the third session of the Conference in order to perform its mandated tasks.

The Government is cordially invited to participate in the fifth meeting of the Open-ended Intergovernmental Working Group on Review of the Implementation of the United Nations Convention against Corruption, which will be held in Vienna, Austria, from 25 August to 2 September 2009.
