

Firstly, we improve the mechanism of responsibility and set up a supervisory organization

Secondly, we earmark funds for designated purposes to ensure safety of funds



CHINA

- I. In order to make good use of special sports funds, we adopt divided management of revenues and expenses, tighten up budget compilation and implementation, and clearly specify the coverage of sports special funds, and the standards, conditions and procedures for applying and using the funds.
- II. We especially focus on managing and inspecting sports special funds dedicated to the training facilities of our national sports teams and the reconstruction and renovation of sports venues.
- III. We have specific working groups to inspect the use of sports special funds, demand timely rectification and accountability for any problems.
- IV. Third-party audit agency is invited to audit sports special funds throughout the entire process.
- V. Our supervision and inspection department has constant and good communication and coordination with the finance department, and continuously improve the internal control mechanism.

3 **Thirdly, we reinforce monitoring and supervision to implement rules of competition**

The monitoring department works closely with the competition administrating departments, establishing and improving selection guidelines, creating monitoring groups, and holding regular briefings on work related to athlete selection.

The discipline committee oversees the fulfillment of responsibility by other competition committees and participating delegations, attending the pre-competition meetings, and intensifying supervision over events where judges or referees have more influence on the results.

The discipline inspection committee looks at the qualifications and conditions for the Sportsmanship Award to ensure that any confirmed case of disciplinary violation or corruption leads to disqualification.

Fourthly, we stick to the “3S” Anti-doping Policy to ensure clean participation of athletes




CHINA

We adhere to the 3S policy, that is Strict Prohibition, Serious Examination and Severe Punishment in the fight against doping.

- we have in place a rigorous system of responsibility. We divide and delegate the power and responsibility, trying to make sure that everyone has a clear function, management at every level goes well.

- we work harder on doping tests, with more than 10,000 samples being tested every year in the past few years, and special attention being paid to sports that requires much physical strength



- we have an anti-doping threshold in the qualification system for athletes. Athletes who have not received education in anti-doping knowledge or failed to pass an examination in this field shall not be qualified for any competition

- we have severe penalties for doping violations. We have a “zero tolerance” attitude towards doping. In case of any positive test, an athlete shall be punished according to The World Anti-Doping Code.

Fifthly, we handle relevant issues in accordance with regulations and severely deal with and punish misconducts violating laws and regulations



The discipline inspection committee carefully handles complaints and reports.

For the received clues, we will stick to collective consultation and make the investigation and verification plan in time. In accordance with relevant regulations, we will seriously investigate and verificate clues and facts.

We will ask relevant organizations to take preemptive measures, resolve conflicts and tackle problems. Certain information will be exposed in time.

We will remind relevant parties to learn a lesson, to strengthen the education and management of the teams, to make sure the athletes respect the referees, opponents and spectators, and observe the competition rules.



6 Sixthly, we fight against illegal match fixing and strive for fair play



CHINA

- ◆ We take actions by carrying out a nation-wide anti-corruption campaign on 3 layers in football.
- ◆ We put forward a couple of long-term measures to fight against corruption in football.
- ◆ We put more efforts into anti-doping and sportsmanship by cracking down on relevant problems in national multi-sports games, championships, League tournaments and Games of provinces, Autonomous Regions and municipalities.
- ◆ We strengthened training, education and supervision for the referees.
- ◆ In early 2015, we stipulated the “Regulation on the national sport competition referee selection and supervision”.



Seventhly, we focus on education and guidance to make people more aware of the importance of rules and regulations





We work hard to improve our education on integrity in sport, enriching the education program, and making it more targeted and efficient.



We run our competitions in a frugal manner and avoid extravagance, and urge various stakeholders to embrace and implement the idea of thrifty and integrity in organizing and participating in competitions.

We simplify the opening and closing ceremonies, streamline the rituals and routes of torch relay, revise and reduce the competition program and team size, and put an end to non-sport and non-competition activities so as to keep sport at the center of competitions.
