

Statement of H. E. Mr Jaideep Mazumdar,
Ambassador and Permanent Representative of India to the UN and
other International Organizations in Vienna
at the 30th Session of CCPCJ

Mr. President,

I wish to extend our warm greetings to you on your election as the Chair of 30th Session of the CCPCJ, as I do to the newly elected members of the Bureau. I do assure you of my delegation's full cooperation in the conduct of this session.

I wish to express our deep appreciation to the Government of Japan for the excellent organisation of the 14th UN Crime Congress on Crime Prevention and Criminal Justice. We would, collectively and individually, strive to achieve the goals set forth in the Kyoto declaration.

Mr. President,

India is signatory to UNCTOC protocols on human trafficking, smuggling of migrants and illicit manufacturing and trafficking of Firearms. To ensure coordinated responses, India has established anti-human trafficking units all over the country besides empowering the high-powered National Investigation Agency to investigate human trafficking cases. Knowing fully well that systematic tracking of fire arms and ammunition from manufacturers to

purchasers are the key to prevent illicit manufacturing and trafficking of fire arms, India keeps updating legislation with provisions for strict enforcement.

India is dealing with Cyber Crime, a major challenge of our times, in a comprehensive and coordinated manner by setting up Cyber Crime Coordination Centre called I4C. National Cyber Crime Reporting Portal, a citizen-centric initiative, is enabling citizens to report cyber crimes online and with ease.

Owing to its size and diversity, the Indian enforcement agencies have rich experience in engaging with multiple issues, ranging from routine Crime investigation, to the Dark Net and Counter Terrorism. India would remain ever willing to share its learnings in the domain of policing, with partners worldwide.

Mr President,

The hallmark of Indian democracy has been that justice is not only guaranteed, but guaranteed on time. To this goal, India has achieved notable success in establishing virtual courts, e-filing, tele-law and National Judicial Data Grid that holds more than 30 million case data. India has taken up an extensive exercise

to make available all Central and Provincial Acts at a single portal named 'INDIA CODE'. We have established a seamless network for tracking crimes and criminals through the Crime and Criminal Tracking Network and System (CCTNS), that shares crime and criminal data among police stations, prisons, forensics for effective and timely justice delivery. These initiatives have come in very handy to ensure access to justice for our vast population especially during the pandemic period.

Mr President,

India, as a nation has adopted zero tolerance towards terrorism and those who aid and abet terrorist acts. We wish to reiterate that the international community should not become complacent, and should act unitedly and decisively against this serious scourge of our time.

Mr. President,

we look forward to meaningful discussions and deliberations in this session which would no doubt contribute to achieving the goals set out in the Kyoto declaration.
