1. INTRODUCTION

The first United Nations Congress on the Prevention of Crime and the Treatment of Offenders is convened in pursuance of resolution 415 (V) of the General Assembly. It is, from an historical point of view, the continuation of the quinquennial congresses previously organized by the International Penal and Penitentiary Commission, the last of which was held at The Hague in August 1950.

2. QUESTIONS TO BE CONSIDERED

The Congress will consider the following items:

- (1) Standard minimum rules for the treatment of prisoners;
- (2) Selection and training of personnel for penal and correctional institutions;
- (3) Open penal and correctional institutions;
- (4) Prison Labour;
- (5) Prevention of juvenile delinquency.

3. ORGANIZATION OF WORK

For the purpose of dealing with the items on its agenda (see I above), the Congress will be divided into three sections which will report to the plenary meetings.

The work of the sections will be allocated as follows:

- Section I: (a) Standard minimum rules for the treatment of prisoners;
- (b) Selection and training of personnel for penal and correctional institutions.
- Section II: (a) Open penal and correctional institutions;
- (b) Prison labour.
- Section III: Prevention of juvenile delinquency.

Each participant will choose the section of which he wishes to be a member. He may, however, attend the meetings of more than one section.

The working languages of the Congress are English, French and Spanish. Speeches made in one of the working languages will be simultaneously interpreted in the two other working languages. Any participant may speak in a language other than one of the working languages if he makes provision for the interpretation of his speech into one of the working languages. Interpretation into the other two working languages may then be based on the interpretation given in the first working language.

32. PALAIS DES NATIONS

Brief history

The Palais des Nations was originally built for the League of Nations. An international competition for a suitable design produced 10,000 drawings and, finally, five architects were chosen to co-ordinate the best ideas.

The Palais contains, in addition to the Assembly Hall, over twenty conference rooms and 800 offices. It has the most modern equipment to ensure its smooth running as a conference centre. The Assembly Hall, the Council Chamber and several of the larger conference rooms are equipped with simultaneous interpretation system enabling delegates, Press and public to follow discussions in all the official languages of the United Nations: Chinese, English, French, Russian and Spanish, all of which goes to make the Palais des Nations the most important international conference centre in Europe.

The Assembly Hall

The Assembly Hall can accommodate nearly 1,500 people.

One of the most celebrated parts of the Palais is the famous lobby of the Assembly Hall, or Salle des Pas Perdus. The floor here is of Finnish granite, and the walls and pillars are covered with Swedish marble of the finest quality.

The Council Chamber

The decoration of the Council Chamber is the gift of Spain.

In the square vestibule by which the room is entered are three bas-reliefs, the gift of the United Kingdom, executed by the English sculptor Eric Gill.

Committee Rooms

Most of the committee rooms open on to a gallery, from which there is an admirable view of the Court of Honour.

The committee rooms vary in their decoration and appointments. For committee room III, panelled in birch and pear wood, Switzerland commissioned the Genevese painter Barraud to contribute a decorative painting representing a boat sailing on placid water.

Room V, the work of White Allom of London, is of notable simplicity. The four large semi-polished olive-green doors depict the architecture of different countries: a New York skyscraper, a Chinese pagoda, and so forth.

Room VI was decorated by Switzerland. On the inner side of the entrance doors are subjects from Swiss history.

Room VII was decorated by Porteneuve, France.

Room VIII, by Petersen of Copenhagen, has wooden panelling and marquetry.

Room IX conveys a less European atmosphere. The panels are of stink-wood, a South African wood noted for the variety and arrangement of its grain.

Room X is the gift of the Latvian Government. The floor is of black oak, inlaid with white wood.

In room XI, Mr. Mutters, of The Hague, has used natural leather for the walls.

Room XII, which was decorated by an Italian firm, is arranged to serve also for cinematograph performances.

These rooms, so varied in style and treatment, testify to the desire of those who constructed the building to achieve in their total effect a harmonious result.

Library

The Library, founded in 1920 by the League of Nations, and thanks to the generosity of Mr. John D. Rockefeller, Jr., housed since 1936 in its own building, is to be found in the furthest wing of the Palais des Nations. This international research centre, built in accordance with the most advanced library planning has space for a million volumes, with study and reading rooms for more than 140 visitors. Its collections (1955: 450,000 volumes; 4276 periodicals regularly received) are at the service of the organs of the United Nations and the specialized agencies and extensively used by delegates, experts, journalists, specialists and students of international questions.

Its publications, the Monthly List of Books catalogued in the Library of the United Nations (28th year, 1955) and the Monthly List of Selected Articles (27th year, 1955) contain information about the latest publications all over the world on politics, law, economics and finance, available on the spot.

The Library is unique in possessing a large collection of manuscripts and autograph letters of many of the world's leading personalities who have championed the ideal of international organizations. Items of major interest (including State papers, busts, portraits, etc.) are assembled in an exhibition room situated on the first floor of the Library wing, and constituting the first international museum of diplomatic history.

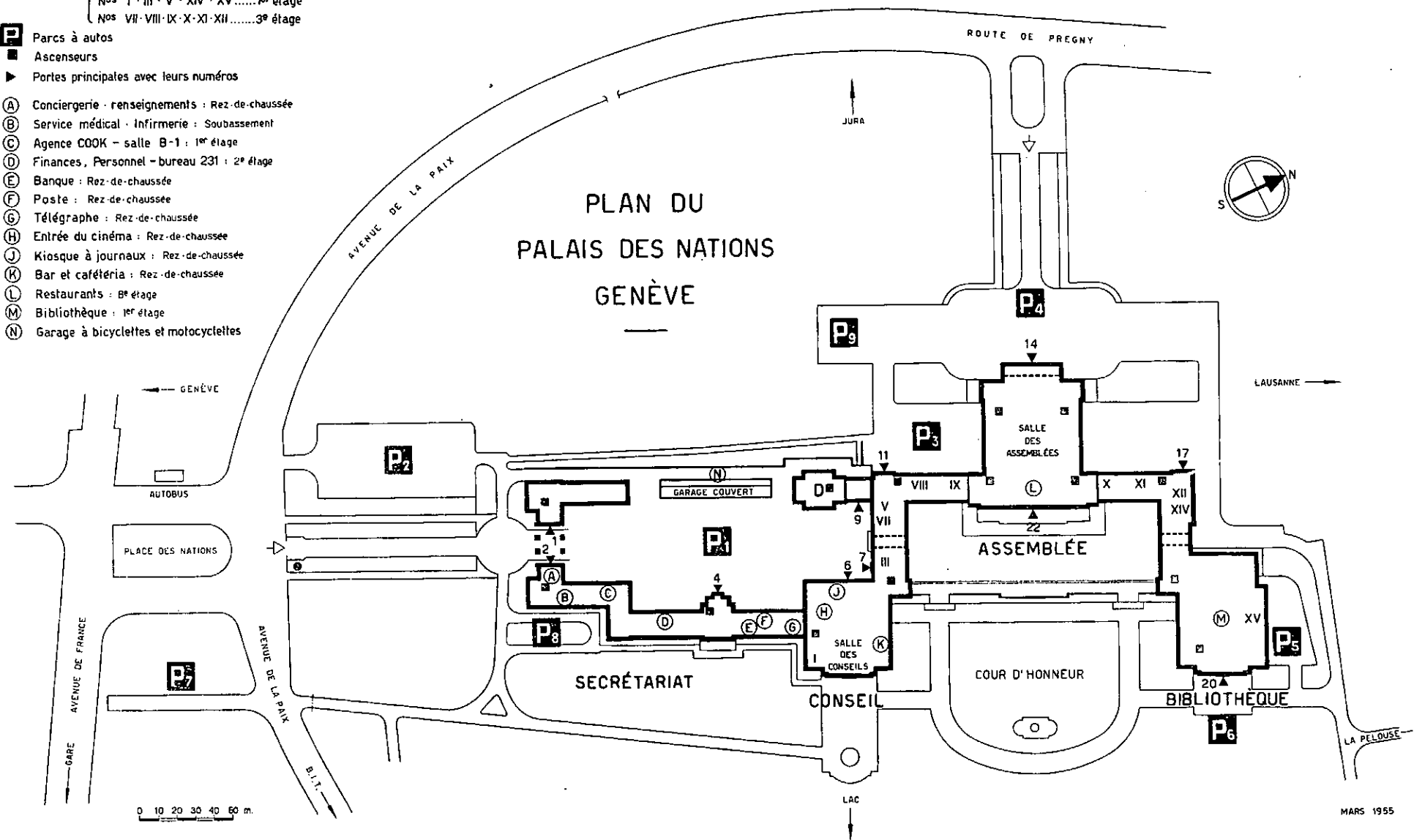
