CREDENTIALS OF REPRESENTATIVES TO THE CONGRESS

Letter dated 31 August 1990 from the representatives of Algeria, Djibouti, Iran (Islamic Republic of), Jordan, Lebanon, the Libyan Arab Jamahiriya, Morocco, Oman, Saudi Arabia, the Sudan, the Syrian Arab Republic and Yemen and the Observer of Palestine to the Eighth United Nations Congress on the Prevention of Crime and the Treatment of Offenders to the Secretary-General of the Congress

The following States - the Libyan Arab Jamahiriya, Palestine, Syria, Lebanon, the Kingdom of Saudi Arabia, Oman, Sudan, Yemen, Jordan, Algeria, Djibouti, the Kingdom of Morocco and the Islamic Republic of Iran - wish to state their reservation regarding the submission by "Israel" of its credentials to, and its representation in, the Eighth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, which is being held at Havana, Cuba, from 27 August to 7 September 1990, on the grounds of the continued violation by "Israel" of the principles and objectives of the Charter of the United Nations, as reflected in its continued illegitimate occupation of Palestine and of a part of the territories of Syria and Lebanon, its non-implementation of the United Nations resolutions requiring an immediate withdrawal from the occupied Arab territories, and its non-recognition of the legitimate and inalienable rights of the Palestinian people, in particular their right to return, self-determination and the establishment of their independent State on their national soil.
