# Inspector General Appoints new Director of Reforms at the National Police Service



Eng. John Patrick Ochieng, Senior Assistant Inspector General (SAIG), was this month appointed the new Director of Reforms at the National Police Service (NPS). Taking over from Mr. King'ori Mwangi AIG, Eng. Ochieng assumes responsibility for coordinating the planning and implementation of NPS reforms across the services. The Basket Fund takes this opportunity to congratulate Eng. Ochieng on his new appointment, and to thank Mr. Mwangi for the excellent spirit of collaboration, which he fostered with Basket Fund representatives.

### The Police Reforms Roadmap

On 14 September, in a meeting with the Basket Fund, the Inspector General affirmed his strong endorsement of the plans for the Police Reforms Roadmap. The Roadmap is the transformation strategy and a mechanism through which the NPS will cascade police reforms down from the headquarter level, via the counties, to the frontline of policing. Pending approval from the Police Reform Steering Committee, and due to commence in early 2016, Roadmap implementation will be strongly supported by the Basket Fund.

### Western Counties welcome IPOA Outreach Campaign

Some 1000 residents and police officers of Kisumu, Kisii and Migori Counties met with Kenya's Independent Policing Oversight Authority (IPOA) on 22–24 September to discuss police reforms in Kenya. IPOA's unprecedented outreach campaign is supported by the Police Reforms Basket Fund, through UNODC. This excursion to Kisumu, Kisii and Migori was the second of five outreach missions. Following visits to Mombasa, Kwale and Kilifi in July, the campaign moves on to Eldoret, Nakuru & Kericho (26-30 October), Kakamega, Busia and Bungoma (9-13 November) and finally to Nyeri, Nanyuki and Murang'a (23-27 November). #### **Transformation Framework**

On 15 September the Inspector General addressed the NPS Nairobi County Commanders at a breakfast meeting at KICC on strategic transformation of the NPS, highlighting the quick win principles of Friendliness, Cleanliness, Orderliness and Respect for the Command Structure. The IG tasked Nairobi County Commanders with implementing these principles at police stations throughout their area. The Basket Fund did not directly support the event, but provided technical assistance in identifying the quick win principles.
