Briefing meeting of NPS Reform Champions

The National Police Service Reform Champions participated in a one-day briefing meeting held on 24 March 2017. The briefing, which was facilitated by UNODC, was aimed at revisiting the key components of Mentoring and Coaching by the Champions – based on previous training undertaken. The Champions were fully equipped in preparation for the two-week long exercise of Mentoring and Coaching of Station and Ward Commanders in the 190+ Stations and Wards.

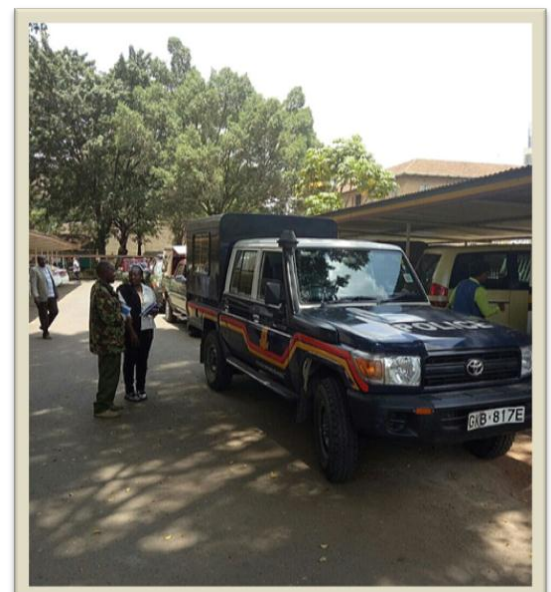

Reform Champions ‘hit the road’ in six Counties to undertake Mentoring and Coaching of Station and Ward Commanders

The National Police Service Reform Champions commenced the implementation of Phase II of the Transformation Roadmap. On 26 March 2017, all the 23 Champions, under the leadership of the four (4) Reform Directors from the National Police Service, the Kenya Police, the Administration Police and Directorate of Criminal Investigations launched the two-week long exercise of Mentoring and Coaching of Station and Ward Commanders in six pilot Counties - Homabay, Migori, Nyeri, Nyandarua, Kisii and Nyamira. The Commanders were presented with the Action Point Work Plan and the mechanism of reporting back on the extent of implementation of the Roadmap.

The journey to Mentoring and Coaching of Commanders getting underway from Jogoo house on 26 March 2017. The Transformation Champions being flagged off to the 6 Pilot Counties.

Illustrations as a medium of communicating the Police Transformation message

UNODC supported the National Police Service to develop and print 50 sets of illustrations. During this phase of Monitoring and Coaching, seven (7) sets of the illustrations, totaling to over 4,000 copies were printed and disseminated. The illustrations were based on various thematic areas, including: the right to bail and bond, misuse of public resources by the police, institutions which members of the public could lodge complaints against the police, corruption – offence to give or receive a bribe and community policing.
