

## **Police Reform in Kenya – Basket Fund Bulletin**

### **Reforms Champions return to counties for the Phase II exercise of Mentoring and Coaching of Station and Ward Commanders**

The UNODC trained Police Reform champions visited 180 Police Station and Ward Commanders across 6 counties from 10-20 June 2017 in a Phase II exercise that was aimed at gauging the progress of implementation of the Roadmap to Transformation of the National Police Service (NPS) in the regions. The exercise was additionally aimed at assisting the Commanders in compilation of progress reports that would later be channeled up the chain of command to the Inspector General of police through a reporting mechanism developed with the assistance of UNODC. The visited stations lay in the regions of Migori, Homabay, Kisii, Nyamira, Nyeri and Nyandarua.

### **NPS Instructors' Induction Programme on the Revised Basic Training Curriculum**

Approximately 600 police instructors from the Kenya Police Colleges are set to benefit from a two-week induction training on the Revised Basic Curriculum. The trainings will be held as from 24 July to 5 August 2017, and will run concurrently at the four (4) policing colleges, namely, Kenya Police Training College-Kiganjo, AP Training College-Embakasi, GSU Training College-Embakasi and GSU Training Camp, Magadi. To facilitate this exercise, 38 trainers were identified and will be the lead instructors for the training. UNODC had previously supported in the development of 21 Training Manuals, derived from the Revised Basic Curriculum.

### **Validation of the draft Programme Document on “Countering Violent Extremism through Anti-Corruption”**

Following a series of consultations with the police, civil society and the media held at the coastal towns of Mombasa and Zanzibar as well as Nairobi between March – May 2017, UNODC presented the draft Programme document to key stakeholders for validation on 6 June 2017. Consequently, it was agreed that the 18-month project will be piloted in Zanzibar (Mwera and Ngambu Police Stations), Mombasa (Likoni and Chagamwe Police Stations) as well as Nairobi (Pangani and Shauri Moyo Police Stations). This Project will focus on the impact of anti-corruption initiatives on acts of violent extremism within the pilot policing communities. This Project will be housed within the Internal Affairs Unit and the Zanzibar Police Commission in Kenya and Zanzibar respectively.
