



Cambodia







Multiple eLearning training delivered

Cambodian law enforcement officers received multiple eLearning training managed by the Border Management Team of the Partnership Against Transnational Crime through Regional Organized Law Enforcement (PATROL) in Phnom Penh, Cambodia. The eLearning modules were available in English and Khmer and covered a wide range of topics such as drug organisations, human trafficking and smuggling of migrants.

Launch of the new course in Arabic

The Anti-Corruption eLearning Course, developed by the Corruption and Economic Crime Branch of UNODC, have been translated and localized into Arabic for users in Egypt and Arabic speaking countries. The first module is an overview of the United Nations Convention Against Corruption, while the second one explores and explains how the Convention, as the only global, comprehensive and legally binding anti-corruption instrument, can act as a framework for the fight against corruption across the globe.

Cook Islands





AML training delivered

The Global Programme against Money-Laundering, Proceeds of Crime and the Financing of Terrorism conducted a training with eLearning content for participants from the Cook Islands. 54% of the trainees were female. The eLearning Programme and the AML Programme cooperates in order to deliver standardized UNODC eLearning capacity-building worldwide.



Fiji

UNODC visited the FIU CBT Centre

Officials of the UNODC visited the FIU CBT Centre and met with the FIJI FIU on the operation of the CBT Centre. Mr Jeremy Douglas, the Regional Representative of the UNODC for the Southeast Asia and the Pacific was invited for a courtesy visit to the FIJI FIU, which provides UNODC's computer-based training courses in Fiji. Mr. Razim Buksh, the Director of the Fiji FIU thanked the UNODC for providing the software training courses.







India

Indonesia

eLearning Training Centre at the National Academy of Customs, Excise and Narcotics

The National Academy of Customs, Excise & Narcotics (NACEN) is the premier training institute working in collaboration with United Nations Office on Drugs & Crime (UNODC). NACEN is imparting training on drug law enforcement to various Asian nations. The Government of India has entrusted NACEN the responsibility of knowledge exchange, experience sharing and training with various countries of the world. NACEN gives place to one of the off-line training centres of the UNODC eLearning Programme. Thanks to its work, the number of law enforcement officers trained by eLearning training courses during 2016 is close to 400.

A new training course – including six modules – On the Narcotic Drugs and Psychotropic Substances is in production for the use of the Government of India in two languages: Hindi and English.

eLearning training to the participants of the Bali Process Meeting in Indonesia

Jakarta Centre for Law Enforcement Cooperation (JCLEC) conducted a training in Semarang, Indonesia to the participants of the Bali Process Meeting. Learners were from Afghanistan, Australia Bangladesh, Cambodia, China, Republic of Korea, Hong Kong SAR, India, Indonesia, Japan, Jordan, Lao PDR, Malaysia, Maldives, Myanmar, New Zealand, Pakistan, Philippines, Singapore, Sri Lanka, Thailand, Turkey, UAE, USA, Vietnam, IOM, and UNHCR. The Global eLearning Programme cooperates with JCLEC since 2010 in order to deliver UNODC eLearning in Indonesia.



Law enforcement students graduation in Indonesia Purwokerto National Police School in Indonesia has the newest lab build by UNODC eLearning Programme and JCLEC. In February 2016, 952 students graduated. All of the graduates benefitted from the study of the UNODC eLearning Programme training modules.







Global Programme against Money-Laundering (GPML)

The Anti Money Laundering eLearning course has been launched in January. In less, than one year the AML eLearning course has close to 500 users. The feedback received from users has been very positive. According to their answers, the course helped them to deepen their knowledge in this field. The gender distribution is as 35% female and 65% male participants.

Kenya



Kenya Wildlife Services adopted UNODC eLearning

Officers of the Kenya Wildlife Services used the UNODC's eLearning modules dealing with scenes of crime as a pre-requisite to attend the two weeks advanced training "Advanced crime scene procedures and techniques to be applied when attending to suspected wildlife crime scenes". The training took place at the KWS Training Institute and provided the officers with a thorough understanding of crime scene management and collection of evidence management of digital evidence, case file compilation, which is aimed to improve the quality of evidence presented on wildlife cases. As per the evaluation of the course by the participants, the E-learning modules provided a good base in preparation for the actual practical course, ensuring that all participants started on common ground.

Lao PDR



eLearning training delivery on mobile tablets for law enforcement officers

The Border Management Team of the Partnership Against Transnational crime through Regional Organized Law Enforcement (PATROL) provided officers in Lao PDR with access to the eLearning training in their languages. This gave the officers from Border Liaison Office opportunity to be trained with eLearning modules on the topics covering UNODC mandate. More countries from the region connected to the eLearning network since then.

Lao's frontline officers from 15 remote border offices receive training

Vientiane (Lao PDR) - Frontline officers from 15 distant border locations across Lao PDR met in Vientiane to share their experiences on harmonized regional procedures to effectively cooperate across borders, and to receive unique BLO Field Tablets and practical training on its use to collect, analyze and share data and intelligence to combat cross-border transnational organized crime.



Liberia

Liberia reached more than 125 persons per month

In the African continent Liberia was the first receiving a Mobile Training Unit in December 2015. The programme has already reached nearly 1,500 beneficiaries. During the first year of using Mobile Training Units, Liberia had more than 125 beneficiaries per month. This number is very impressive, considering that the delivery of the same training on a traditional way would needed at least 5 training workshops for 25 participants. The average yearly training cost is \$35/beneficiary, exemplifying the cost-effectiveness of the eLearning services.



Malaysia

AML eLearning course

In May, the Global Programme against Money Laundering, Proceeds of Crime and the Financing of Terrorism (GPML) received an official request from the Financial Intelligence Unit (FIU) of Malaysia to have staff members registered for the Anti Money Laundering (AML) eLearning course. A total of 90 staff members were provided access to the AML course. It is expected to have around 300 new users per year.





Myanmar



eLearning training to Police

The Border Management team provided eLearning training to 18 officers in Myanmar. They came from nine different police stations of the capital, Naypyidaw.



eLearning trainings delivered

The Border Management Team of the Partnership Against Transnational Crime through Regional Organized Law Enforcement (PATROL) delivered capacity-building training in Kawthaung, Tachileik and Myawaddy, in Myanmar. UNODC eLearning contents and tablets were used during the 3 training in May. A total of 36 police officers received access to the UNODC eLearning contents in Burmese and English. The trainings focused on drug organisations, human trafficking, smuggling of migrants, wildlife crime, land border interdiction and container profiling and examination.





Pakistan

New eLearning modules in Urdu

Three new Urdu modules have been produced in order to train Pakistan Officers to prevent the smuggling of migrants under the title of 'Introduction to Smuggling of Migrants', 'Investigative Approaches to Smuggling of Migrants' and 'Investigative Techniques to Counter the Smuggling of Migrants'. The modules take a great emphasis on primary investigative approaches and discuss the importance of treating migrants as victims of a crime and to respond accordingly to obtain essential evidence. The modules cover the use of specific investigative techniques for a more effective action against crimes.



Pakistan Federal Investigation Agency and UNODC launched eLearning Centre

Mr. Cesar Guedes UNODC Pakistan Country Representative inaugurated a computer-based training "e-learning centre" for the Federal Investigation Agency of Pakistan.

The representatives from FIA including Dr Usman Anwar, Ian Hudson, and Delia Mills from Australian High Commission and Martin Banks from the United Kingdom's High Commission were also present.

According to FIA officials, after inaugurating the centre Guedes thanked the High Commissioner of Australia Ms Margaret Adamson for generously funding the development of the e-learning centre. He appreciated the FIA support and willingness to develop their expertise in order to overcome a multitude of challenges including human trafficking, migrant smuggling and other forms of transnational organised crimes.

Guedes lauded the efforts of UK High Commissioner Thomas Drew for especially enabling the UNODC to develop a dedicated modern "Interviewing Room" in addition to assisting the FIA to digitalise its paper record for the first time.





Sierra Leone



eLearning Assessment in Sierra Leonne

The eLearning National Project Officer for ECOWAS conducted an eLearning assessment mission in Freetown, Sierra Leone.

The purpose of the Assessment was to plan the production and delivery of a Mobile Training Unit (MTU).

The UNODC Staff met with local law enforcement officers to introduce the eLearning programme, to visit training facilities and to assess their readiness for conducting an eLearning Training for Trainers.

eLearning in Thailand

Thailand is a long-lasting partner and represents a prominent place in the delivery of eLearning. The training campaign of the Royal Thai Police—Police Educational Bureau (RTP PEB) has reached 2250 certified users in the utilization of the Mobile Training Units. Thailand has provided trainings to 6 training centres so far in Ubonratchathani, Undorthani, Songkla, Yala, Lampang and Surat Thani. The delivery of mobile trainings of "Human Trafficking" is in progress to a further 19 police training centres all over Thailand.

Sri Lanka



Training Centres of Sri Lanka

The two training centres in Sri Lanka (Kaluthara Police Academy and National Drug Control Board, Colombo) have trained 6567 eLearning law enforcement officers since the launch of the Programme. This number is a clear representation of interest and cooperation.













Thailand's frontline officers harness new technology to combat cross-border crime

Bangkok (Thailand) - Recognizing the importance of data collection and information sharing, 12 law enforcement officers from eleven Thai Border Liaison Office (BLO) locations and headquarters travelled from their border areas to Bangkok to participate in a hands-on, one-day workshop on utilizing technology to collect and share cross-border crime information.

The officers received access to all of UNODC's specialized training material on investigating transnational organized crime translated into local languages. The officers were also given access to eLearning, which allows them to further their professional development through interactive online courses available in their native language. By training the officers on innovative data collection techniques and providing them with standardized resources for self-learning, the Regional Border Management Programme is helping to strengthen the capacity of frontline officers to counter networks of transnational organized crime.





Timor Leste

eLearning Centre established at Police Headquarters

UNODC Global eLearning Programme established an eLearning Centre with localised modules and a "training for trainers" to the Police Headquarters in Dili, Timor- Leste. Eight police officers, including the National eLearning Focal Person, were trained on the use and deliveries of new eLearning technology.





Tonga

Two eLearning training delivered

Alongside with the Global Programme against Money-Laundering, two training have been delivered in Tonga. Police officers were trained through UNODC eLearning contents.





Vietnam





eLearning training for Police

Vietnam is one of the most active countries in terms of delivery. Officers from six different Police Border Liaison Offices (BLO) have been trained by the Border Management team using eLearning contents. The officers who took part in the training originated from southern provinces of Viet Nam. Training were delivered in Vietnamese and aimed to improve capacity building for law enforcement officers, especially those at the border control management. All officers passed the knowledge assessment successfully and received the eLearning Programme certificate of completion.



BLO Trainings in Vietnam (ROSEAP)

Frontline multi-agency law enforcement officers from six Border Liaison Offices (BLO) gathered for a weeklong training on anti-smuggling techniques to counter transnational organized environmental crimes in the city of Long Xuyen, Viet Nam.

An international and national team of experts delivered the practical training to improve the capacity of the thirty participating officers to detect, interdict and communicate cross-border smuggling crimes as part of UNODC's Border Management Programme for Southeast Asia and the Global Programme for Combating Wildlife and Forest Crime.



UNODC Vietnam hosted a series of specialised eLearning training courses on transnational organized crime including human trafficking, smuggling of migrants, wildlife crime and illegal logging for officers from the four BLO locations; one in Nghe An Province, one in Ha Tinh Province and two in Quang Tri Province. The training aimed to improve the capacity for law enforcement officers to better address transnational organized crime in different forms. The focus on eLearning also teaches the officers how to utilize new technology provided by UNODC to further their own professional development through standardized, international training modules available in their local language.
