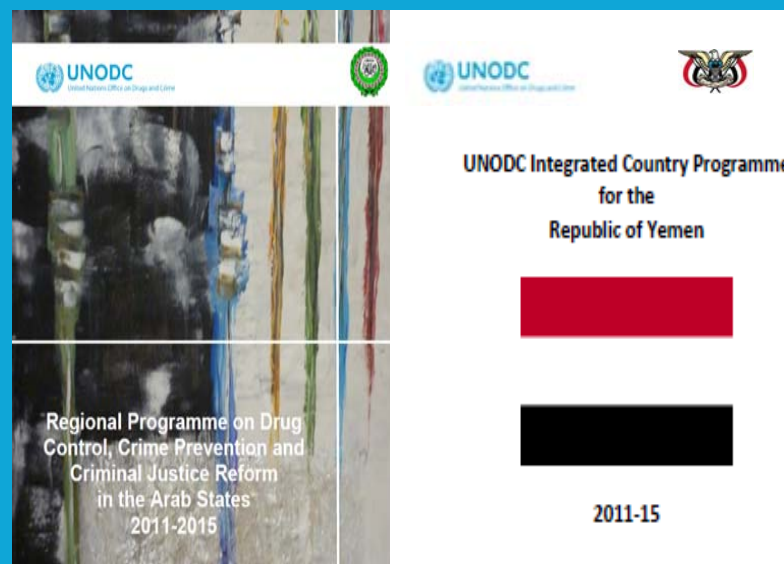


Integrated Country Programme for the Republic of Yemen 2011-15



Background

18 Arab States endorsed the Regional Programme on Drug Control, Crime Prevention and Criminal Justice Reform for the Arab States 2011-2015 in Cairo, Egypt in April 2010 and requested that Integrated Country Programmes be developed for Yemen and the Occupied Palestinian Territory

Development of Draft Country Programme July - September 2010

Outcomes

Sub-Programme I Counter Drugs, Trafficking and Criminal Networks



Strengthening border security against illicit trafficking, smuggling and cross-border organised crime

Enhanced national capacity for effective and strategic management and oversight of drug trafficking (including counterfeit medicine) investigation through the criminal justice system

National capacity increased to prevent and combat trafficking in human beings and smuggling of migrants

The Republic of Yemen's capacity to engage in regional efforts to combat maritime crime and piracy is enhanced

More effective investigation of criminal cases (including serious crimes)

More effective prosecution of criminal cases (including serious crimes)

Penitentiary system and conditions improved in line with international standards

Access to justice is improved and increased throughout the Republic of Yemen

Strengthened response to combat corruption and promote integrity

Enhanced capacity of all law enforcement actors to implement the rule of law throughout the Republic of Yemen

Awareness increased and progress achieved on the need to adhere to and implement the international legal framework against terrorism

New counter-terrorism legislation adopted, and existing legislation revised in accordance with the international legal instruments against terrorism, relevant Security Council Resolutions, and the rule of law

Increased capacity of criminal justice officials, especially those serving in the specialised counter-terrorism courts to apply domestic legislation in the effective investigation, prosecution and adjudication of complex terrorism cases in compliance with human rights standards

Strengthened regional cooperation especially with countries of East Africa, and enhanced capacity to participate in international cooperation in criminal matters pertaining to terrorism
