Background

Corruption poses significant threats to countries around the world; it weakens institutions, erodes trust and threatens the economy by undermining fair competition and discouraging investment. It also disproportionately affects disadvantaged groups, especially the poor, preventing social inclusion and promoting inequality.

A number of governance indicators reveal that corruption remains a significant obstacle to development of countries in the Southern Africa region, notably the Members of the Southern African Development Community (SADC). In recognition of the global character of the threats posed by corruption, the United Nations Convention against Corruption (UNCAC) was adopted as the sole global legally binding international instrument against corruption. As a complementary regional effort, the SADC Protocol Against Corruption aims to promote and strengthen, within each Member State, the development of mechanisms needed to prevent, detect, punish and eradicate corruption in the public and private sector, facilitate and regulate cooperation in matters of corruption amongst Member States and foster development and harmonization of policies and domestic legislation related to corruption.

The far-reaching approach and the mandatory nature of most of the provisions of the UNCAC and the SADC Protocol Against Corruption make them a unique tool for developing a comprehensive response to a global problem in SADC countries. However, challenges remain with regard to their implementation, including the effective and timely implementation of the recommendations from the country reviews conducted under the UNCAC Implementation Review Mechanism.

The effective implementation of the Convention requires actions by State actors but building partnerships and enhancing cooperation with private sector entities, civil society organizations, academia, youth and the general public is equally fundamental for the fight against corruption. These stakeholders are key for the exchange of knowledge, data and best practices to enable comprehensive discussions for the advancement of the UNCAC and SDG 16.

Under the framework of the programme entitled "Fast-Tracking UNCAC Implementation", UNODC established a regional platform for Southern Africa in October 2019, bringing together participating countries around the four thematic priority areas: inter-agency cooperation, whistle-blower protection, asset disclosures and conflicts of interest in public procurement. The platform allowed stakeholders to focus on concrete reforms in those priority areas while creating synergies and partnerships with other anti-corruption and regional development partners, leading to strengthened coordination and collaboration within the SADC countries in thematic areas common to both the UNCAC and the SADC Protocol against Corruption.

As an active expression of its support from both partner and donor countries, resolution 9/4 entitled "Strengthening the

implementation of the United Nations Convention against Corruption at regional levels" was adopted by the Conference of States Parties to UNCAC at its ninth session in December 2021. With it, the Conference notes the contribution of such regional approach and requests UNODC to continue and expand its methodology, in close cooperation with multilateral and bilateral assistance providers, based on the requests and priorities of recipient countries.

Furthermore, in 2021 UNODC adopted its Strategic Vision for Africa 2030 that sets out safeguarding people and institutions from corruption and economic crime as one of the Vision's five goals. The Vision commits UNODC to supporting Africa in realizing the 2030 Agenda for Sustainable Development as well as to help achieve the continent's own Agenda 2063: The Africa We Want.

Objectives of the conference

It is against this backdrop that a regional conference bringing together all **SADC Members around two anti-corruption priorities** is being organized.

The overall objective is to agree on a **common roadmap for all SADC Members** containing a set of recommendations and commitments **for realization of the two anti-corruption priorities**.

Thematic areas:

The conference will focus of the following two thematic areas identified as priorities for the SADC region:

- · National and Regional Coordination
- · Public Procurement

Methodology and structure of the conference

The objective of the Regional Conference is for participating countries to firstly conduct detailed technical meetings on the two thematic areas identified and secondly develop a list of priority commitments to strengthen the implementation of the Convention in their countries to be endorsed at the last day of the conference.

The Regional Conference will be organized as a **two-stage process**.

During the first stage and the technical segment, only Governmental Technical Experts will be participating.

UNODC is inviting two technical experts from each participating country (one per thematic area) to participate in the first stage.

Participating countries are kindly invited to identify the relevant technical experts to conduct the discussions and draft recommendations during this stage.

Two Governmental Technical Experts per group will be invited to stay for the entire duration of the conference and act as the spokesperson. The **spokesperson** will be required to:

- Draft the PowerPoint presentation during the drafting session
- · Deliver a presentation at the Dry Run Session
- · Deliver a presentation at the High-Level Segment

First stage: Technical Segment (29 and 30 May 2023)

Technical Segment: This first stage of the conference will be dedicated to detailed technical discussions on the two thematic areas. The objective of this first stage is to develop a set of recommendations and commitments based on the results of the sessions.

Day one - 29 May 2023: After a joint opening session, Governmental Technical Experts will be invited to conduct parallel working sessions.

Participating Governmental Technical Experts will be divided into two thematic groups to conduct discussions and reach an agreement on possible commitments for the identified priorities.

Day two - 30 May 2023: Governmental Technical Experts will continue to work in their respective thematic groups.

At the drafting session stage, the Governmental Technical Expert spokespersons will be invited to stay with the facilitator of their groups to draft the PowerPoint presentation to be delivered.

The last day of the first stage will be concluded by a dry run session: each group's spokesperson will deliver the PowerPoint presentation in plenary session. After each presentation, the floor will be opened to all participants for comments, suggestions and agreement.

Civil Society and Private Sector parallel Roundtable 30 May 2023:

30 May 2023: On the second day of the conference, civil society private sector organizations and representatives of the academic world, will meet to hold a Roundtable discussion in parallel with the work of the technical group, on the importance of dialogue and joint action between the government and civil society in preventing and detecting corruption. The objective of this roundtable will be to discuss the role and impact of non-governmental groups in preventing and combating corruption, as well as entry points for strengthening their actions by working in coordination and collaboration with governmental bodies.

Second stage: High-Level Segment (31 May -2 June 2023)

The objective of this second stage is to discuss about key elements on strengthening the implementation of the United Nations Convention against Corruption at regional level and allow for the endorsement of a commonly agreed roadmap containing a list of priority commitments and recommendations to strengthen the implementation of the UNCAC and the SADC protocol, as part of the two thematic areas identified as regional priorities.

Day One - 31 May 2023: After a formal opening ceremony, national decision and policy makers, high level representatives, members of the civil society and private sector as well as development partners will meet to discuss the opportunities and challenges of combatting corruption through a strong and integrated regional approach.

Two panels will be presented in an interactive format on the following topics:

- · Implications and benefits of resolution 9/4.
- Collective action to ensure good governance: how the regional platform can help in strengthening the prevention and fight against corruption.

These panels will be presented by representatives from Egypt, Latin America, West Africa and the Sahel, Southeast Europe and the Balkans, Southeast Asia, and the International Anti-Corruption Academy.

Day Two - 1 June 2023: This second day of the high-level segment will include the governmental experts' spokespersons as well as the governmental decision and policy makers and high-level representatives of the SADC countries. The spokespersons of each thematic area will be invited to deliver the presentation of the draft roadmap as agreed by the technical segment. After each presentation, the floor will be open to all participants for comments, suggestions and agreement.

Final Day - 2 June 2023: A UNODC representative will introduce a Word document that will contain the entire list of recommendations and commitments as discussed during the preceding working sessions of the conference to the participants for final endorsement.

The floor will be opened to all participants for comments and suggestions using a "point-by-point" method. The amendments suggested by the Plenary participants will be directly reflected live in session on the projected document. The objective of this working session is the final endorsement of the document.

High-level representatives, decision and policy makers of participating countries who would not have the possibility to attend the entire High-Level Segment are strongly encouraged to prioritize their attendance of the final session.
