**UNODC Indonesia** and **Support to the Fight against Corruption** invite the public, media and interested parties to a presentation of results from two anti-corruption research efforts.

The first, *"Best Practices of Bureaucracy Reform Implementation in Prevention of Corruption in Denpasar and Tanah Bumbu"*, is based on research by Transparency International Indonesia (*Tranparansi Internasional Indonesia*, TII) in cooperation with Indonesia Corruption Watch (ICW).

This research examines the effectiveness of the Government's bureaucratic reform program in improving transparency and public services and reducing corruption in the City of Denpasar, Bali, and the Regency Government (Pemkab) of Tanah Bumbu, South Kalimantan.

The second study, *"Research on Coordination and Supervision Function of Indonesia's Corruption Eradication Commission (KPK)"*, was conducted by ICW and Indonesian and international experts and facilitated by UNODC Indonesia.

This study identifies the institutional and operational obstacles that hinder a coordinated response by the KPK, the Indonesian National Police and Attorney General Office public prosecutors to prevent and prosecute corruption cases – and makes recommendations to improve anti-corruption cooperation and responses by law enforcement and prosecutors.

This event is organized by **Support to the Fight against Corruption** with the assistance of UNODC Indonesia, the European Union, the Government of Norway, GTZ, ICW, Transparency International and the Basel Institute of Governance. **Support to the Fight against Corruption** is a UNODC Indonesia project that is financially supported by the European Union and the Government of Norway. UNODC Indonesia is the lead agency and its partners are Transparency International Indonesia (TII) and Indonesia Corruption Watch (ICW), while UNODC associates are the Basel Institute on Governance and GTZ.

The event supports the Indonesia Government's National Strategy for the Prevention and Eradication of Corruption (Nastra-PEC) 2012-2025. A key goal of Nastra-PEC is to build and strengthen corruption prevention systems in national, provincial and local governments, state agencies and ministries, and to support Indonesia in ratifying the UN Convention against Corruption (UNCAC).
