## **DESCRIPTION OF REQUIREMENTS**

The United Nations Office on Drugs and Crime (UNODC), Country Office Pakistan hereby invites qualified Quetta based Non-Governmental Organizations (NGOs) to submit Expression of Interest for implementation of a project on "Drug Related HIV Prevention Services to People Who Inject Drugs (PWID) in Community of Quetta, Balochistan Province".

The duration of the service delivery will be six months and mainly include the establishment of mobile outreach services, awareness raising on drug related HIV prevention, syringe exchange services, voluntary and confidential counseling and testing, basic health care, STIs prevention education and syndromic management, condoms, education on safe practices, referral for advanced medical care, referral for drug abuse treatment, referral of HIV positive to care and support services. The services will be provided through outreach services.

Detailed Specification/ requirement will be provided in the tender document at a later date.

Only organizations meeting the below criteria will be considered:

- 1. NGO registered with the Government of Pakistan (Submit proof of registration)

- 3. At least 5 years of experience in providing Harm Reduction Services to People Who Inject Drugs (PWID) (Provide proof of relevant work/experience/projects and at least 2 references)
- 4. Quetta based NGO (Provide proof of presence of the NGO in Quetta)
- 5. Audit reports of the NGO for the last two (02) years should be submitted.
