

GoCase installation in the Corruption Eradication Commission



Jakarta (Indonesia), 17 October - 04 November 2011 – In mid October until the first week of November 2011, UNODC has installed the goCase software in the Corruption Eradication Commission (KPK). The

goCase is intended to support KPK in enhancing its coordination and supervision (C&S) function of cases investigated by themselves and the Indonesian National Police as well as the Attorney General's Office. The installation of the software in the KPK was followed by a three weeks training for KPK investigators, pre-investigators, trainers, C&S team, public complaints division and IT staff. Over 30 people were trained in its use, which also included on the job training. UNODC IT Service staff, Ms. Stella Du Toit and Mr. Shad Al Abani, were the lead trainers who also provided IT support to the Commission.

GoCASE is an investigative case management and intelligence analysis system developed by Information Technology Service of UNODC for the use of law enforcement, investigative, intelligence, regulatory and prosecution agencies worldwide. The goCASE installment is made possible under the European Union funded project "Support to the fight against corruption".

Indonesia to take steps forward in addressing transfer of sentenced persons



Jakarta (Indonesia), 9 to 10 November 2011 – UNODC Indonesia and the Australian Government Attorney-General's Department

organized a workshop on "International Transfer of Prisoners". Presentations were held by specialists of this field representing the Government of Australia, Government of Indonesia, Ministry of Law and Human Rights of the Republic of Indonesia, The Council of Europe and the Department of Justice of the Philippines.

A number of countries, namely Australia, Hong Kong, Brazil, India, Iran, Malaysia, and Nigeria proposed to conclude a Treaty on the Transfer of Sentenced Persons (TSP) with Indonesia which exhibits the keen interest shown by them. The non - existence of a national law on the TSP, lack of common understanding among stakeholders and the inadequacies in national infrastructure were considered as the primary impediments to implementation of TSP. The participating parties emphasized that Indonesia needs to set out these principles in legislation and the workshop identified these major issues and discussed probable remedies to mitigate them.

Building understanding in West Papua to fight illegal logging



Manokwari (Indonesia), 10 November 2011 – UNODC held a workshop on "Illegal Logging and Corruption in

the Forestry Sector". The workshop provided a platform for law enforcement officers/ agencies and civil society organizations to share and discuss the issues related to illegal logging and its association with corruption in the forestry sector in West Papua as well as the response of law enforcement to forestry crimes. The objective of this initial workshop was to enhance coordination and cooperation between law enforcement and civil society to combat illegal logging, and define measures to be adopted to enforce the forestry law, anti-corruption law and anti-money laundering law against the perpetrators of illegal logging.

40 participants from District Court, District Attorney, Police, Provincial Forest Service, Natural Resources Conservation Centre, civil society and local media attended the workshop. This workshop was made possible through the funding of Royal Norwegian Government for the project; 'Countering Illegal Logging and the linkage between Forest Crime and Corruption in Indonesia'.

Towards the National Strategy on the Prevention and the Eradication of Corruption

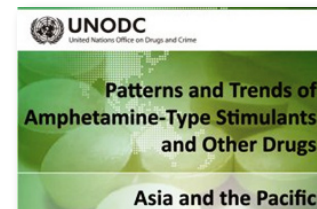


Jakarta (Indonesia), 15 and 17 November 2011 – UNODC held two high level workshops in order to finalize

the National Strategy on the Prevention and Eradication of Corruption (STRANAS PPK). The workshops focused on the finalization of STRANAS PPK in the Ministries and Agencies and on the development of an Action Plan for 2012. The draft STRANAS PPK is likely to be submitted by the National Development Planning Agency, as the caretaker, to the President for its launch soon.

Present at the workshops were multidisciplinary experts and representatives from Presidential Working Unit for Supervision and Control of Development, Secretariat of the Vice President, Judicial Mafia Eradication Task Force, KPK, Ombudsman and Transparency International Indonesia. These workshops were made possible through the European Union funded project - 'Support to the Fight Against Corruption in Indonesia'

Methamphetamine rise in East and South-East Asia threat to security and health



Jakarta (Indonesia), 29 November 2011 – UNODC launched the "2011 Patterns and Trends of Amphetamine-Type Stimulants

and Other Drugs, Asia and the Pacific" Report which highlights the latest patterns and trends of ATS - a market which includes amphetamine, methamphetamine, methcathinone, and ecstasy-group substances - as well as other illicit drugs in East and South-East Asia. It also provides overviews for the neighbouring regions of South Asia and the Pacific.

The launch in Jakarta started with a brief remark by the UN Resident Coordinator for Indonesia, Mr. El-Mostafa Benlamih, continued by keynote speech by Mr. Gories Mere, Head, National Narcotics Board (BNN) of the Republic of Indonesia and the Report was presented by Mr. Gary Lewis, Regional Representative, UNODC Regional Centre for East Asia and the Pacific.

Improving the law enforcement in forestry sector



Jakarta (Indonesia), 29 November 2011 – Workshop on "Coordination to Tackle Illegal Logging and Corruption in Forestry Sector"

was organised by UNODC in order to identify barriers and challenges faced by law enforcement agencies and forestry officials and to determine the opportunities to use the Anti-Corruption and Money Laundering Law in addition to the Forestry Law to ensnare those involved in illegal logging and corruption in the forestry sector. Moreover, this workshop aimed to improve coordination and cooperation among law enforcement officials in handling cases of illegal logging and corruption.

Participants of this workshop were 32 representatives comprising of Judges, prosecutors, police and forestry officials from national and regional levels, namely from the Province of Papua, West Papua and Central Kalimantan. Also present were representatives from Indonesian Financial Transaction Reports and Analysis Centre and Anti-Judicial Mafia Task Force, who all have recommended that equalization of knowledge in forest crime is needed, Forestry Law, Environmental Law, Anti-Corruption Law and Money Laundering Law should be synergised and finally, Inter-agency coordination should be strengthened commencing from prevention and law enforcement.
