II. Organizational Context

Under the overall supervision of the Regional Representative of UNODC and the technical guidance of the Regional Programme Officer, HIV/AIDS Prevention and Care, Southern Africa (ROSAF) and the UNODC Prevention, Treatment and Rehabilitation Section (PTRS), the Programme Officer will be responsible for providing on-going technical guidance and policy advice on the UNODC's Prevention, Treatment, and Rehabilitation efforts in the region by addressing drug demand reduction and addressing drug use disorders as a multifactorial health disorder, that is by supporting countries in the region in their efforts of implementing evidence-based drug use prevention and evidence-based drug use disorder treatment and care strategies in line with the UNODC/WHO International Standards for Drug Use Prevention and the UNODC/WHO International Standards for the Treatment of Drug Use Disorders - including for children and adolescents, based on scientific evidence, human rights and gender considerations.

This position is situated in the framework of UNODC global project GLOK32 – Partnerships for the Treatment of Drug Use Disorders including the UNODC-WHO programme on Drug Dependence Treatment and Care – and the incumbent will be responsible for the day-to-day management of the Southern African segment of GLOK32 in close coordination with UNODC ROSAF and UNODC PTRS. Initially activities will have a focus on quality assurance for treatment of drug use disorder services and systems.

III. Functions:

• Assist the Government in the assessment, mapping of the drug use disorder treatment treatment and rehabilitation situation, resources in the key areas, support the development of effective strategies and reviewing and adapting national policy and implementation plans.

- Assist the Government in building national capacity for enhanced policy and service delivery development, coordination, sound monitoring and evaluation with regard to drug use use disorder treatment and rehabilitation in line with the UNODC/WHO International Standards for the Treatment of Drug Use Disorders
- Organise and participate as a resource person in relevant meetings and capacity building events on drug use disorder treatment and care, including on quality assurance for the treatment of drug use disorder treatment services and systems, advocacy meetings, roundtables, training workshops and other meetings related to drug use disorder treatment and care, particularly for people who use drugs, people with drug use disorders in the community and in prison settings and persons with drug use disorders in contact with the criminal justice system.
- Provide substantive support to meetings and conferences including proposing agenda topics, identifying and proposing participants, preparing background documents and presentations, and supporting administrative aspects.
- Review, analyse, and evaluate technical reports and other relevant materials on the state of the art of drug use prevention, treatment and care and facilitate dissemination of good practices.
- Facilitate the establishment of technical working groups involving all relevant stakeholders at the national level.
- Represent UNODC in the technical working groups, inter-agency task force, and other relevant forums.
- Ensure the project management of project GLOK32 in Southafrica and the Southern African region as requested, including budget reviews, regular reporting, preparation of work plans, progress reports, analytical reports etc.
- Contribute to programme/grant proposals/ concept notes development for various donors, to ensure their technical soundness and appropriateness in the context of drug use prevention, treatment and care and related mental health and HIV prevention and care.
- Support fundraising through research, preparation of proposals and facilitating consultations with donors and counterparts, as requested and in close coordination with ROSAF and PTRS
- Assist the Regional Coordinator in coordination, implementation, monitoring and reporting of related health pillar activities as feasible and requested
- Design and implement technical assistance activities in South Africa related to drug use prevention, treatment and care among people who use drugs and with drug use disorders, in the community and in prison settings with a priority to activities to be implemented in the framework of UNODC project GLOK32 in close coordination with ROSAF and PTRS
- Prepare reports such as reports to the HQs, Regional Office, Government and donors.
- Conduct consultations with the government agencies, health service providers, civil society partners and other stakeholders to facilitate the development, implementation and evaluation of drug demand reduction, harm reduction activities.
- Perform other functions as required.

IV. Impact of Results

The key results have an impact on the proper action and efficiency of the Programme. Accurate analysis and presentation of information strengthens the capacity of the Office and promotes the image of the UNODC as an effective contributor to the response on drugs and crime and especially health and drug use disorder treatment and related areas (mental health, HIV prevention, drug use prevention, justice sector) related issues in the country. Incumbent's own initiative as well as coordination with ROSAF and PTRS is decisive in results of work and timely finalisation.

Experience and knowledge on evidence-based drug use disorder treatment and care to guide national counterparts in their efforts to assess and improve national drug se disorders treatment service and systems is key for this position. Effective planning, development, organization, coordination, implementation, monitoring of UNODC policies, programmes and activities; timely and efficient delivery of assigned tasks and responsibilities; development of well-reasoned and innovative approaches; provision of well-researched and sound analysis and expert advice on drug use disorder treatment and care related developments in the country; effective dissemination of best practices and methodologies; organization and delivery of specialized training; effective liaison and interaction with relevant parties internally and externally.

Provides well researched and sound analysis of issues affecting programme/project development, administration and implementation. Effectively, and in a timely manner, liaises and interacts with colleagues and concerned parties internally and externally. Provides effective substantive, technical assistance in the organization and delivery of training and in servicing of committees and meetings. Effectively assists supervisors in meeting project objectives and outputs. Narrative skills to provide effective communication on UNODC projects to all stakeholders.
