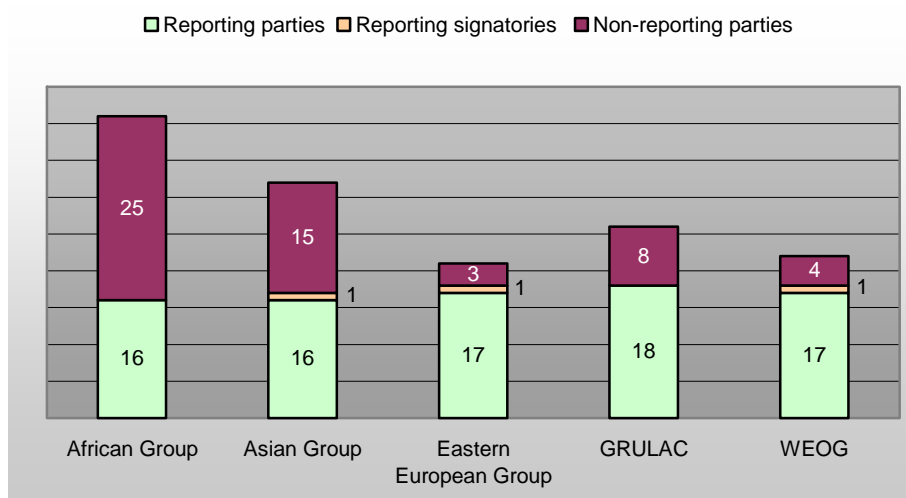

2. Non-reporting States parties (25): Benin, Burundi, Cameroon, Cape Verde, Central African Republic, Democratic Republic of the Congo, Djibouti, Ethiopia, Gabon, Ghana, Guinea-Bissau, Lesotho, Liberia, Libyan Arab Jamahiriya, Madagascar, Malawi, Mali, Mozambique, Niger, Sao Tome and Principe, Senegal, Seychelles, South Africa, Zambia, Zimbabwe.

### B. Asian Group

3. Reporting signatories (1): Bhutan.

### C. Eastern European Group
