I. INTRODUCTION

Sports-related crimes, such as money laundering and bribery, and fraudulent activities, such as match-fixing, involving sophisticated organised crime groups, have grown exponentially in recent time. This is due in part to inadequate or non-existent governance structures in many sports associations. Furthermore, in the limited number of cases where legislation does exist to address these issues at a national level, implementation issues often arise. The additional complexity created by the international dimension of these crimes and activities often means that offenders remain unpunished.

The objective of this side event is to look at the issue of integrity and legacy in sport from four perspectives, namely those of investigators, international organisations, civil society and businesses.

Panellists and participants will be invited to consider the following questions:

- What are the realities and challenges faced by investigators in uncovering integrity violations?
- How can the application of the UNCAC provisions, and use of tools developed by UNODC and its partners, contribute to promoting integrity and anti-corruption in sports?
- How existing policies can address the challenges faced by investigators in the field and how new policies can be developed to mitigate opportunities for organised crime in sports?
- How can companies engage in sport sponsorship and hospitality in a transparent manner in such a way as to promote and enhance integrity and ethics in sport? Discussion will also focus on the role that companies can play, as sponsors promoting prestige and accountability, to foster the adoption as well as full enforcement of anti-crime legislation and policies in sports.
