**Making the UNCAC Review more Effective**

**I. INTRODUCTION**

Representatives of the government, civil society and UNODC will present and discuss proposals for enhancing the review mechanism to ensure that UNCAC reviews produce meaningful results. The event is intended to foster discussion and will provide ample time for contributions from the audience.

A key focus of the upcoming CoSP will be the UNCAC review mechanism, its mechanics and how it could be improved. The success of the UNCAC ultimately depends on the effectiveness of its review mechanism.

The mechanism has thus far exceeded expectations both in terms of how the process is conducted and the quality of the outputs. Nevertheless, all parties to the Convention are still on a learning curve and there is much room for improvement.

This side event brings together a number of actors with a particular interest in the mechanism from various perspectives. They will present proposals for its improvement and discuss with interested participants, complementing the closed door informal processes where future plans will also be discussed.
