##### 1. Organizational matters

###### (a) Opening of the session

The continued resumed second session of the Implementation Review Group will be opened on Tuesday, 25 October 2011, at 10 a.m., in Plenary II — Toubkal, at the Palmeraie Golf Palace Complex in Marrakech, Morocco.

###### (b) Adoption of the agenda and organization of work

The proposed organization of work for the continued resumed second session (see annex) was prepared in line with the guidance provided by the Implementation Review Group at the first part of its second session, held from 30 May to 2 June 2011, in order to enable it to consider the agenda items within the time and conference services available.

At the first part of its second session, the Implementation Review Group agreed that, pending a decision by the Conference of the States Parties on the participation of observers, invitations for the continued resumed second session would be extended in the same manner as for the first part of the session.

The resources available will permit the holding of two plenary meetings with interpretation in the six official languages of the United Nations.



**2. Review of implementation of the United Nations Convention against Corruption: follow-up to the second session with emphasis on discussion of the thematic reports on chapters III and IV of the Convention**

Thematic implementation reports compiling the most common and relevant information contained in country review reports are to be prepared by the secretariat and submitted to the Implementation Review Group. Owing to the delays experienced in finalizing country review reports in the first year of the review cycle, the thematic reports were not available in all official languages at the resumed second session of the Group. The Group decided that it would hold a continued resumed second session to consider the thematic reports.

**3. Other matters**

In considering item 3 of the agenda, the Group may wish to take up other outstanding matters.

**4. Conclusions and recommendations**

At its resumed second session the Implementation Review Group decided to add an item to its agenda entitled "Conclusions and recommendations". The Group is to consider the conclusions and recommendation made by the Group since its first session in order to give full consideration to the results of its work for appropriate transmission to the Conference of the States Parties to the United Nations Convention against Corruption, in accordance with its mandate.

**5. Provisional agenda for the third session of the Implementation Review Group**

The Implementation Review Group is to consider and approve a provisional agenda for its third session, which will be drafted by the secretariat in consultation with the Chair.

**6. Adoption of the report of the Implementation Review Group on its continued resumed second session**

The Implementation Review Group is to adopt a report on its continued resumed second session, the draft of which will be prepared by the secretariat.
