1. Organizational matters

(a) Opening of the session

The resumed second session of the Implementation Review Group will be opened on Wednesday, 7 September 2011, at 10 a.m. in Conference Room 1, M-Building (M1).

(b) Adoption of the agenda and organization of work

The proposed organization of work for the resumed second session (see annex) was prepared in line with the guidance provided by the Implementation Review Group at the first part of its second session, held from 30 May to 2 June 2011, in order to enable it to consider the agenda items within the time and conference services available.

At the first part of its second session, the Implementation Review Group agreed that, pending a decision by the Conference of the States Parties on the participation of observers, invitations for the resumed second session would be extended in the same manner as for the first part of the session.

The resources available will permit the holding of two plenary meetings each day with interpretation in the six official languages of the United Nations.
