

# Schedule of Meetings in the week of 5-9 September 2022

(status as at 1 September 2022\*)

The below tables contain an informal schedule of meetings which will take place during the week of 5 to 9 September, i.e. the intersessional meeting of the Conference of the States Parties to the United Nations Convention against Corruption (CoSP) on the achievements of the political declaration adopted by the special session of the General Assembly against corruption (UNGASS) (5-8 September 2022), and the first resumed thirteenth session of the Implementation Review Group (IRG) (8 and 9 September 2022).
