Reference: CU 2015/98(A)/DTA/CEB prevention of corruption

The Secretariat of the Conference of the States Parties to the United Nations Convention against Corruption presents its compliments to the [[[AddressLine1]]] and has the honour to draw the attention of the Government to resolution 5/4 of the Conference, entitled “Follow-up to the Marrakech declaration on the prevention of corruption”.

In that resolution, the Conference of the States Parties decided that the Open-ended Intergovernmental Working Group on the Prevention of Corruption, established by Conference resolution 3/2, should continue its work to advise and assist the Conference in the implementation of its mandate on the prevention of corruption. The Conference also decided that the future meetings of the Working Group should continue to follow the multi-year workplan for the period up to 2015 and the start of the second cycle of the Review Mechanism, as agreed by the Working Group.

The Conference further decided that the Working Group on the Prevention of Corruption shall hold at least two meetings prior to the sixth session of the Conference.

The Government is cordially invited to participate in the **sixth meeting of the Open-ended Intergovernmental Working Group on the Prevention of Corruption**, which will be held in Vienna, Austria, from **31 August to 2 September 2015**.

The Secretariat takes this opportunity to remind the Government that, as approved by the Conference in its resolution 5/4 entitled “Follow-up to the Marrakech declaration on the prevention of corruption” and in accordance with the conclusions of the Working Group at its fifth intersessional meeting held in Vienna from 8 to 10 September 2014 (CAC/COSP/WG.4/2014/5, paragraph 8), the topics for discussion at the forthcoming sixth intersessional meeting of the Working Group to be held in Vienna from 31 August to 2 September 2015 will be:

(a) Measures to prevent money-laundering (article 14) and;

(b) Integrity in public procurement processes and transparency and accountability in the management of public finances (articles 9 and 10).
