The Permanent Mission of the Republic of the Union of Myanmar to the United Nations in Vienna presents its compliments to the Secretariat of the Conference of the States Parties to the United Nations Convention against Corruption, the United Nations Office on Drugs and Crime (UNODC) and, with reference to the latter's Note No. CU 2016/111(A)/DTA/CEB/ISS dated 26 April 2016 regarding the seventh intersessional meeting of the Working Group on the Prevention of Corruption, has the honour to forward herewith the following information received from the Myanmar Anti-Corruption Commission -

(a) The use of information and communications technologies for the implementation of the Convention in order to facilitate public sector transparency and combat corruption

(1) In relation to the article 9 - public procurement and management of public finances and article 13 - participation of society of the Convention, discussion are to be made in the fields of preparation and arrangement for the use of ICT, specific challenges, and required and provided technical assistance. Since those are under the Convention's Chapter 2 - Preventive measures, the evaluation of the implementation of the Chapter 2 of the Convention is to be made in the second cycle (2016-2020).

(2) As Myanmar is finalizing its first cycle of the evaluation of the implementation of the Convention, the self-assessment checklist prepared by Myanmar is only for the evaluation of the first cycle, i.e. Chapter 3 - Criminalization and law enforcement and Chapter 4 - International cooperation of the Convention.

(b) The protection of integrity in sport by promoting good governance in sport and mitigating the risk of corruption that sport faces

(1) In relation to this, discussion are to be made in the areas of preparation and implementation of the prevention of corruption, preparation for investigation and prosecution of

criminal offences link to sport integrity in the context of legislation, and required and already received technical assistance. This topic is to be discussed under the Resolution 6/6: Follow-up to the Marrakech declaration on the prevention of corruption.

- (2) Myanmar held anti-corruption dissemination workshops and seminars at all the Union Ministries as well as at the States and Regions Governments during 2015.
