The secretariat of the Conference of the States Parties to the United Nations Convention against Corruption presents its compliments to the [[[AddressLine1]]] and has the honour to draw the attention of the Government to resolution 7/5 of the Conference of the States Parties, entitled “Promoting preventive measures against corruption” and resolution 7/6, entitled “Follow-up to the Marrakech declaration on the prevention of corruption”.

In accordance with these resolutions, the Government is invited to participate in the **tenth session of the Open-ended Intergovernmental Working Group on the Prevention of Corruption**, which will be held in Vienna, Austria, from **4 to 6 September 2019, Boardroom B/M1, M-Building, Vienna International Centre**.

In considering their travel arrangements for this meeting, delegations are urged to take into account the agenda and programme of work of the Implementation Review Group (IRG), to be held from 2 to 4 September 2019, in view of the goal to maximize the cross-fertilization of the discussions held by the Working Group on Prevention and the IRG. In this regard, it is recalled that, in accordance with the multi-year work plan for the analytical work, as agreed for the IRG and the other subsidiary bodies for the period 2017-2019, the main focus of the first resumed tenth session of the IRG will be on prevention.
