# WHO Recommendations: Document /12 (1) – 1961 Convention as amended



- Recommendation to place **butonitazene** in Schedule I of the 1961 Convention as amended

## 1961 CONVENTION

**Decisions are taken by a simple majority of the Commission members present and voting. “Members present and voting” in this context means members casting an affirmative or negative vote. Members that abstain from voting are considered as not voting.**

# WHO Recommendations: Document /12 (2) – 1971 Convention

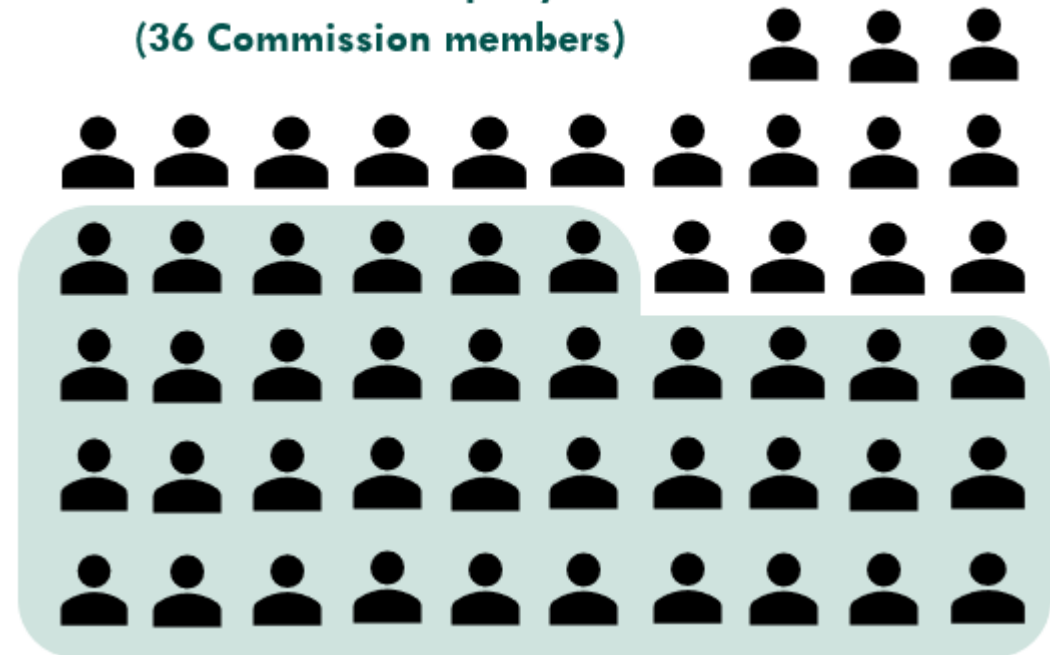


Recommendations to place

- **dipentylone** in Schedule II of 1971 Convention

- **bromazolam** in Schedule IV of 1971 Convention.

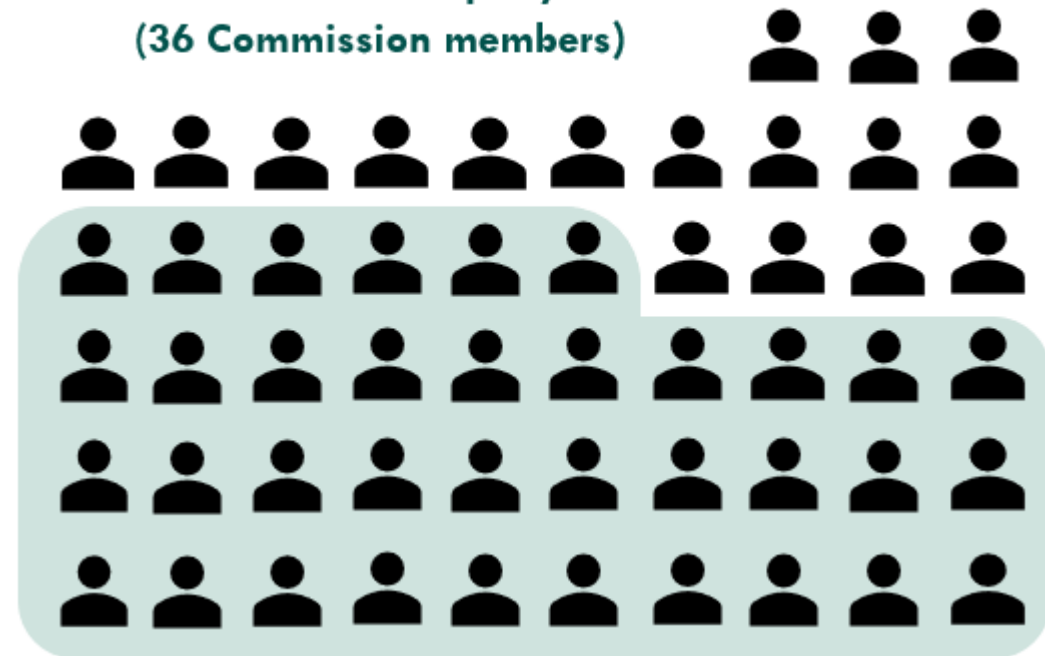

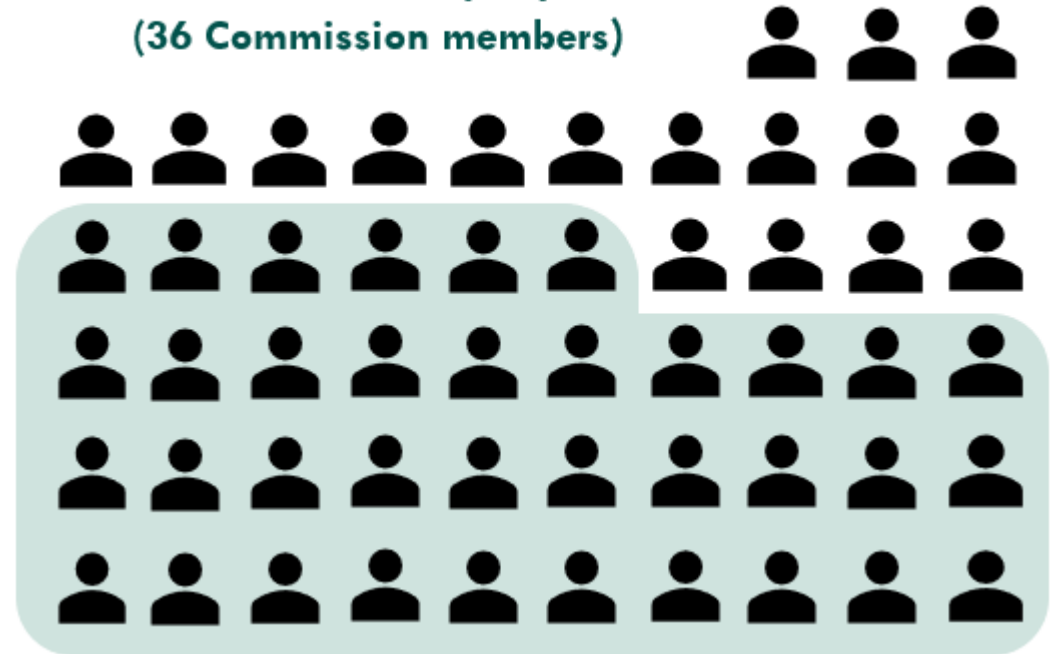
